Rules and Regulations for Participation



- 1. Participation :** Application for participation is to be made in the prescribed form. Acceptance of participation and exhibits will be at the sole discretion of The Belgaum Chamber of Commerce and Industries, Belgaum (BCCI).
 - 2. Booking :** Full payment at the time of booking. In case of cancellation no refund will be made. All payments are to be made by crossed draft / cheque in favour of FINVEST '10, Belgaum payable at Belgaum. A refundable security deposit of Rs. 10,000/- (Rs. Ten Thousand Only) per stall to be paid along with stall rent. Security deposit amount will be refunded within Fifteen days of conclusion of FINVEST '10 Exhibition.
 - 3. Name on Fascia :** Exhibitors display name has to be submitted at the time of booking.
 - 4. Allocation of stall / space :** Allocation will be done by BCCI on first - come - first - served basis only on receipt of full payment towards space booked and other applicable payments. Space will be allotted to exhibitors only. No subletting / transfer in whole or part will be allowed. Decision of BCCI in this regard will be final and binding on the exhibitors.
 - 5. Allotment of Stall / Space :** Stall/space to exhibitors will be given one day before the opening of the exhibition. Display arrangement will have to be completed strictly before opening of the exhibition.
 - 6. Construction of Stall :** The interior design of stalls / space booked will have to be within the architectural controls specified by BCCI. Exhibitors will not be allowed to use passages for construction, wood work, painting of stand and storage of exhibits. BCCI will have the right to levy penalty in all such cases or to recover damages. Work regarding construction of stall will be permitted within the area allotted. Exhibitors will be responsible for removal of empties, waste material before the opening of the Exhibition. Cleanliness and maintenance of stall will be the responsibility of the exhibitors.
 - 7. Display :** Display of advertisement or products, other than bonafide exhibitors will not be allowed inside and outside of the exhibition area.
 - 8. Operation of Stall/Space:** No stall/space will be left unattended during the exhibition. Staff of exhibitors must be present. Activity, which in the opinion of BCCI amounting to nuisance or annoyance, will not be allowed. BCCI shall have the right to take remedial action in such cases. Fire extinguishers, cable terminals, outlets of electricity etc must not be obstructed.
 - 9. Security :** BCCI will make general security arrangements. However, Exhibitors will be responsible for the security of their exhibits and stall/ space.
 - 10. Fire Prevention :** Exhibitors will keep and maintain fire-fighting equipment within their stalls as per safety regulations. Arrangements of fire extinguishers in stall/pavilions is the responsibility of the exhibitor.
 - 11. Insurance:** Exhibitors will insure their representatives, display material etc. against loss, damage, theft, fire or any other causes whatsoever. They will also obtain third party insurance cover for installation, exhibition and dismantling period.
 - 12. Vacation of Stall/Space :** Stall/Space will have to be vacated before 12 noon on the succeeding day after conclusion of exhibition failing which, exhibitors will be required to pay penalty as prescribed by BCCI & organizers will have the right to remove the, exhibits/material etc, at the risk and cost of exhibitors.
 - 13. Service Agencies:** Work of cargo handling, cleaning construction of stall, decoration, furniture and catering can be availed by the exhibitors only from those contractors who are appointed by BCCI. No other contractors will be allowed to provide services in the Exhibition premises.
 - 14. Entry :** Entry of service vehicles in the Exhibition premises will not be permitted during exhibition period.
 - 15. Exit Permit :** Exit permit will be required for taking out any material out of the exhibition premises during the exhibition period. Exit Permits will be issued by the Central Control room BCCI.
 - 16. Automobile exhibitors :** Automobile exhibitors should display their vehicles within the allotted area only. No test run/ ride of vehicles will be allowed within & around the exhibition premises.
 - 17. Electrical Installations :** All on -site electrical installation must be carried out by officially appointed electrical contractor of BCCI.
 - 18. Additional :** Additional electrical points, furniture etc will have to be intimated one day prior to the commencement of FINVEST '10 exhibition. Cost of these additional items to be borne by stall exhibitors.
 - 19. Parking :** No visitor's car/vehicle parking will be allowed within the Exhibition Premises. Cars/vehicles will be parked in the parking areas only.
 - 20. Violation of rules :** In the event of violation of these rules, BCCI shall have the right to close down the stall of the exhibitor forthwith.
 - 21. Interpretation :** The decision of President, The Belgaum Chamber of Commerce & Industries, Belgaum (BCCI) or his nominee shall be final and binding on the exhibitors regarding interpretation of rules and regulations.
 - 22. Disputes:** Disputes if any, arising out of participation in the Exhibition, shall fall within the jurisdiction of the courts in Belgaum.

- 23.** The organizers shall have lien on the goods and display material of the exhibitors if any payment remains due at the end of the exhibitors on any account.
 - 24.** BCCI reserve the right to amend/make necessary changes in the layout, specification, terms and condition, dates of the exhibition.
 - 25.** In case of exhibition FINVEST '10 Belgaum being cancelled or suspended in whole or in part due to causes beyond the control of organizers, BCCI Belgaum does not accept any responsibilities to make good the loss arising to the exhibitors.
